

BBQ Side Dish Recipe Contest – Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN

The BBQ Side Dish Recipe Contest (“Contest”) is sponsored by the Idaho Lottery (“Sponsor”). By entering this Contest, participants agree to abide by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Contest.

Contest Period

The Contest begins on May 15, 2026 and ends on June 15, 2026 at 11:59 p.m. MT. Entries received after the Contest Period will not be eligible.

Eligibility

Contest is open to legal residents of Idaho who are 18 years of age or older at the time of entry. Employees of the Idaho Lottery and their immediate family members are not eligible to participate.

How to Enter

Participants may enter by submitting an original BBQ side dish recipe during the Contest Period through the Idaho Lottery’s website or social media channels.

Each recipe submission should include:

- Recipe title
- Ingredient list
- Preparation instructions
- Entrant’s name and contact information, including phone number and email address.

Limit one (1) entry per person unless otherwise stated by the Sponsor.

Recipe Requirements

Recipes must:

- Be original work created by the entrant
- Be appropriate for public distribution
- Not infringe upon any copyright, trademark, or other rights of any third party
- Be suitable as a BBQ side dish recipe

Sponsor reserves the right to disqualify any entry deemed inappropriate, offensive, incomplete, or otherwise non-compliant with these Official Rules.

Judging & Winner Selection

Eligible entries will be judged by a panel selected by the Idaho Lottery based on criteria including:

- Creativity
- Originality
- Taste appeal
- BBQ pairing appeal

Three winners will be selected:

- **1st Place:** \$500 in BBQ Bucks Scratch tickets
- **2nd Place:** \$300 in BBQ Bucks Scratch tickets
- **3rd Place:** \$100 in BBQ Bucks Scratch tickets

Publication & Use of Recipes

By submitting a recipe, entrant grants the Idaho Lottery a perpetual, royalty-free, irrevocable license to use, publish, reproduce, modify, distribute, and display the submitted recipe, entrant's name, and hometown in any media now known or later developed, including but not limited to digital publications, websites, social media, promotional materials, and recipe books.

All submitted recipes may be included in a digital recipe book made available through the VIP Club in July.

By entering, participants acknowledge and agree that:

- The Idaho Lottery may publicly distribute and promote submitted recipes without additional compensation or approval
- Entrants waive any claims against the Idaho Lottery relating to the use, publication, or distribution of submitted recipes
- Entrants will not sue or hold the Idaho Lottery liable for the Idaho Lottery's authorized use of the submitted recipe

General Conditions

The Idaho Lottery reserves the right to cancel, suspend, or modify the Contest if fraud, technical failures, or any other factor impairs the integrity or proper functioning of the Contest.

Winner Notification

Winners will be contacted using the information provided at entry. If a winner cannot be contacted or fails to respond within the designated timeframe, an alternate winner may be selected.
